

Sybille Reiß to become TUI Group's new Chief Human Resources Officer and Labour Director

- **Change in the Executive Board as of 1 July 2021**
- **Extensive international experience in HR management and as member of Management Board of TUI Deutschland, with TUI since 2003**
- **Dr Elke Eller announced in December 2020 that she would not be renewing her contract**

Hanover, 11 May 2021. The Supervisory Board of TUI AG today decided to appoint Sybille Reiß (45) to the Executive Board as TUI's new Chief Human Resources Officer and Labour Director with effect from 1 July 2021. As part of the Human Resources function, she will also take over responsibility for Security, Health and Safety from Dr Elke Eller, who had established this department. Elke Eller had announced in December 2020 that she would not renew her Executive Board contract which was scheduled to expire in autumn 2021.

Sybille Reiß has worked very closely with Elke Eller in the past and has helped to shape all strategic HR programmes and set the course.
