This document provides answers to frequently asked questions regarding TUI Green IT Supplier Award 2024.

Frequently Asked Questions (FAQs)

General

What is the TUI Green IT award?

- The TUI green IT awards create an opportunity for TUI's IT suppliers to share their sustainable innovations, initiatives, and actions. The aim of the award is to create a community of change makers with our IT suppliers and partners.
A key objective of the awards is to establish ongoing dialog and exploration with our partners to create a more sustainable future.

How do I apply for a sustainability award?

- Suppliers can submit their sustainable initiative via an online survey, sharing information such as what problem they are solving, what their initiative was, how it was delivered, what benefits were achieved and most importantly what potential the project has for TUI and the tourism industry & how TUI can support to drive this forward.

What are the benefits of entering the TUI Green IT Award?

- A key objective of the award is to establish ongoing dialog and exploration to create a more sustainable future.
Winners will be advertised on the TUI Group website & social platforms and can share their achievement on their own platforms with a winners logo.
Participants can become part of a community of changemakers to help drive sustainability of and by Technology. Winners will be invited to share their knowledge with our TUI colleagues.

Are there different categories within sustainability awards?

- Participants will submit their sustainable initiatives, aligned to one of our 3 sustainability pillars: people, planet, or progress.
Entries to the **People** category should empower people to drive development, these Initiatives help local people and communities benefit from tourism.
The **Planet** category is for initiatives which reduce environmental footprints.
Initiatives in the **Progress** category aim to accelerate the transformation, these initiatives should use scale to increase the positive social and environmental impact of holiday experiences.

What languages are accepted for the application?

- English is the preferred language for all applications.

Is there a fee to apply for a TUI Green IT award?

- Entering the TUI Green IT Award is free, there are no charges.

Who can apply for a TUI Green IT award?

- The supplier must be an existing or previous technology or technology related services' vendor of TUI Group (whether software, services, hardware, or platforms).

Can previous award winners apply again in subsequent years?

- Yes, past winners are eligible to apply again with new initiatives or significant improvements or changes to previous submissions.

Is there a deadline for submitting applications for the Green IT Award?

- The deadline for applications is 15th December 2023.

Your project/initiative

Are there any specific data or metrics you're looking for in the application?

- For your entry to be considered you need to have yielded verifiable, quantified results showing improvements. We know each project is unique and will therefore have its own KPIs or metrics, therefore we do not request any specific measures.

Can projects that are still in the planning phase be submitted?

- The submitted Sustainability initiative must have been running and/or completed in the 24 months immediately preceding your submission and must have yielded verifiable, quantified results.

Can I enter more than one sustainability initiative?

- Yes, we would love to hear about as many sustainable initiatives as possible particularly if you have initiatives which fit into a different category.

Saving your entry

Can I save my application and continue later?

- Yes, click the 'save and continue' button at the bottom of the page, enter your name and email address then you will be sent a link to continue the application.

Is there an opportunity to update or modify the application after submission?

- You can save your application and return complete it at a later time. Once submitted you cannot modify the application.

Where can I find a list of the questions contained in the application?

- A list of the questions you will be asked for your application can be found in the appendix of the terms and conditions in the dedicated webpage.

How are the TUI Green IT award winners selected?

- All entries will be reviewed and shortlisted ready for a final assessment by a panel of internal TUI judges who will choose three winners which will be announced in March 2024.

- Winners will be contacted, and results of the award will be shared on the TUI Group website.
